Report from Helge Hansen, Forest Manager

The papers relating to the autumn felling are ready to be signed. A meeting with the contractors is scheduled for the official start date of 8th August. The need for the contractors to avoid disturbance to identified badger setts was stressed. RR,PS and CD will monitor activity.

NV and HH will between them make at least 3 site visits each week and liaise closely with the contractors.

No road closures are envisaged before mid October.

The new forest car park will be closed to allow lorries to use it as a turning area. Cars will temporarily have to park on the approach road.

The need for the contractors to reinstate the paths to a high standard was agreed. HH will discuss this with the contractors prior to the contract being signed.

Fencing work is due to restart on the 6th August.

HH and NV have met again with Jim Mann to explore the possibility of using pigs in ACF to improve the ground. The Board expressed their support for advancing the project.

Leader project path work will begin on 26th August for 2 weeks. HH will discuss machinery hire and labour requirements with Chris Marsh.

A routine FSC internal audit will take place on 22nd August. HH and NV will make appropriate preparations.
